West Anderson Water District routinely monitors constituents in your drinking water according to Federal and State laws. This table shows the results of our monitoring for the period of January 1st to December 31st 2023. All drinking water, including bottled water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these constituents does not necessarily pose a health risk.

In this table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we have provided the following definitions:

Non-detects (ND) laboratory analysis indicates that the constituent is not present.

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to 1 minute in 2 years, a single penny in \$10,000 or 1 ounce in 7,350 gallons of water.

Parts per billion (ppb) or Micrograms per liter- 1 (ppb) corresponds to 1 minute in 2000 years, or a single penny in \$10,000,000, or 1 ounce in 7,350,000 gallons of water.

Action level – The concentration of a contaminant that, if exceeded, triggers treatment or other requirements that a water system must follow.

Maximum Contaminant Level (mcl) The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the (MCLG) as feasible using the best available treatment technology. **Maximum Contaminant Level Goal (MCLG)** – The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no known risk to health. (MCLG)s allow for a margin of safety.

Maximum Residual Disinfectant Level Goal (MRDLG) – The level of a drinking water disinfectant below which there is no known or expected risk to health. (MRDLG)s do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Maximum Residual Disinfectant Level (MRDL) – The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Coliforms are bacteria that are naturally present in the environment and are used as an indicator that other, potentially harmful, waterborne pathogens may be present or that a potential pathway exists through which contamination may enter the drinking water distribution system. We found coliforms indicating the need to look for potential problems in water treatment or distribution. When this occurs, we are required to conduct assessment(s) to identify problems and to correct any problems that were found during these assessments.

Level 1 Assessment: A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.

During the past year we were required to conduct one (1) Level 1 assessment. Samples taken by an independent laboratory were transported incorrectly, which resulted in the Total Coliform Positive results. Once this was remedied, all subsequent samples were absent. At no time was our water system compromised.
